The operator is obliged to notify the licensing authority of commencement of business within 6 months from the date of service of the license, on pain of its revocation (Article 14(4) of the act). At the same time in accordance with Article 14 paragraph 1(8) of the act, I set out the basic obligations of the operator in the event of cessation of conduct of business activity covered by the license.

In the event of cessation of conduct of business the operator is required to:

1. Secure the weapons and ammunition, as well as the records related to the trade in weapons and ammunition, in accordance with valid regulations;

2.

- a) promptly divest the accumulated weapons and ammunition through the agency of an operator holding a license in the same scope, or
- b) place the weapons and ammunition in deposit with an operator holding an appropriate license.
- 3. Placing weapons and ammunition in deposit does not constitute an obstacle to their divestment as specified in point 2a;
- 4. Promptly notify the licensing authority and the competent Police body of cessation of conduct of business and the manner of securing of weapons and ammunition, and also indicate the manner of securing of documents related to the records referred to in point 1.

Pursuant to Article 107 § 4 of the act of June 14, 1960 - Code of Administrative Procedure (Journal of Laws of 2016, it. 23), the decision does not require a statement of reasons since it grants the request of the party in entirety.

ADVICE

A party dissatisfied with the decision may, within fourteen days of the date of service of the decision, file a request for reconsideration of the matter (Article 129 § 2 in connection with Article 127 § 3 of the act of 14 June 1960 Code of Administrative Procedure).

Any possible appeal against the decision to the Provincial Administrative Court in Warsaw may occur after exhaustion of the above-mentioned remedy - Article 52 § 1 and § 2 of act of 30 August 2002 Law on proceedings before the administrative courts (Journal of Laws of 2012, item 270, as amended).
